

**Please Note:** If a Student Member wishes to continue with their training and eventually apply for Registered Practitioner Membership Level, for a six (6) month period after they receive their Level I certification, they must complete the required practicum. Completion of twenty four (24) practicum forms or a combination of practicum and CEU forms, totaling twenty four (24) hours of practice time is required. CEU forms may be used when attending a CRA hosted Reiki Exchange or when attending a Student Practice Night hosted by a CRA Registered Teacher. Upon completion of the six (6) month practicum period and completion of twenty four (24) hours of practice, the Student Member is eligible to apply for Registered Practitioner Membership Level.

### **Registered Practitioner**

To qualify as a CRA Registered Practitioner, the applicant will have studied and successfully completed a minimum of Level I or first degree Reiki class and will have completed the required practicum. They will submit the required forms along with their application and the applicant will sign and abide by the CRA Code of Ethics and the Disciplinary Action Policy forms. ### **Registered Teacher**

To qualify as a CRA Registered Teacher, the member will have studied and successfully completed the minimum teaching requirements for the style of Reiki they studied which will consist of three (3) or four (4) levels of training depending on Lineage. This will not be less than three (3) levels consisting of a minimum of twenty eight (28) hours of training in total. The member will have practiced Reiki for a minimum of twice a week for a minimum of one (1) year from the time they received certification as a Reiki Master/Teacher. The member will read, sign and agree to abide by the CRA Code of Ethics. The member will follow the CRA Educational Guidelines and continually support their students by answering questions and be encouraged to host at least one student practice night per month for the purpose of issuing CEU's to student members.

Registered Teacher applicants must submit to the CRA copies of their class outlines in theory and practical for review. *Class outlines may be submitted by email in PDF to [membership@reiki.ca](mailto:membership@reiki.ca),*

*faxed or mailed to the CRA.* They must also visibly display their CRA designation and their CRA Registration number on every certificate they issue to their students. **Example:** RT 01-054 will be displayed beside the Teacher's name.

### **To Apply for Membership**

Carefully check the Membership Criteria for each level of membership, especially if you are applying as a **Registered Practitioner** or a **Registered Teacher**. Membership Criteria may be viewed at [www.reiki.ca/criteria.htm](http://www.reiki.ca/criteria.htm).

Complete the appropriate Membership Application. Sign and date the **Code of Ethics** and the **Disciplinary Action Policy Forms** if you are applying for Student, Practitioner or Teacher membership level.

If you are applying as a Registered Practitioner or Teacher, don't forget the **Referral Section** at the bottom of the application form.

If you are applying as a Registered Teacher, you will also need to obtain, fill out, and sign the **Educational Guidelines** as well and carefully read the additional Membership Criteria at [www.reiki.ca/criteria.htm](http://www.reiki.ca/criteria.htm). Plus you will need to submit copies of your class outlines in theory and practical for review.

## **Who we are**

**The Canadian Reiki Association:** We provide our members with a national voice and encourage high educational standards. Through our Code of Ethics, we promote ethical practices and teaching. We assist the public with referrals to CRA Registered Practitioners and Teachers and are committed to enlightening and educating our communities about Reiki.

## **What we stand for**

First and foremost, we believe in equality. In becoming members of the Canadian Reiki Association, our Practitioners and Teachers express their support for the idea that all styles of Reiki are equally valid and that no one style of Reiki is better or more authentic than another. While CRA members support holistic healing, we understand that Reiki is not superior to allopathic or other complementary interventions, but rather is an additional method of addressing the issue. We believe in the therapeutic effectiveness of Reiki, both as a freestanding therapy and/or in conjunction with other modalities.

## **What is Reiki?**

Reiki (pronounced Ray-Key) is an energy-based healing modality. In use since the early 1900s, it is a discipline with ties to traditional Japanese and Chinese medical theory. A non-invasive technique, Reiki is used on its own merits as an effective way of assisting with a variety of ailments. It is particularly good for inducing relaxation, reducing pain and stress, increasing vitality, assisting the body's natural healing abilities, and generally giving one a sense of balance. Reiki can also be used in conjunction with other therapies (medical, psychological, and body-work, to name a few) to enhance the benefits and results that these modalities provide.

Treatments do not involve pressure, manipulation or massage. Reiki practitioners rest their hands gently on or above specific areas of one's clothed body, and energy is projected directly into the energy field and drawn into the physical being by the client. This energy is self-dispersing; it flows naturally into deficient areas and also assists your body in re-balancing its own energy.

## **What we offer the public**

On request, the CRA will provide you with the names of several of our Registered Practitioners and Teachers in your area. Our members have agreed to abide by our Code of Ethics and educational standards, so

you can be confident that you will be dealt with fairly and ethically. You have the added security of knowing that there is an association to which you can bring your concerns or questions.

Should you wish, the CRA may be able to provide you with speakers who can address the topic of Reiki at your continuing education lectures, workshops, or conferences.

## **Credentialing**

As recognized by Health Canada, complementary healing modalities are self-regulated. All CRA teachers give students a certificate upon completion of each level. These certificates must be presented to the CRA upon registering as a member of the organization.

## **Fees for services**

The individual Practitioner sets all fees. The CRA does not wish to interfere in the marketing efforts of its members.

## **What we offer our members**

The CRA provides Reiki Practitioners and Teachers with a common voice. Newsletters help keep you up to date on social, legal, political and other issues from coast to coast.

There are selected municipalities in Canada that will only issue business licenses to Reiki practitioners on two explicit conditions. They must be a member in good standing with the Canadian Reiki Association and present to the licensing office their original C.R.A. certificate with the current membership year sticker.

All members receive a wallet size identification card indicating their affiliation to the C.R.A. and they are entitled to use the designation RP-CRA or RT-CRA. All members upon request may list their name in the C.R.A. directory and receive the added benefits of our referral network. This listing is available to all potential clients and students who visit our website
